

### **Revision of eIDAS regulation**

REGULATION (EU) 2024/1183 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 11 April 2024 amending Regulation (EU) No 910/2014 as regards establishing the European Digital Identity Framework

- Came into effect 20<sup>th</sup> May 2024
- Introduces the EU Digital Identity Wallet, to be provided by every
   EU member state
- Introduces new qualified trust services, esp. "electronic attestation of attributes" and "management of remote qualified electronic signature creation devices"
- QWAC to be recognized by providers of web-browsers

### NIS2/Cybersecurity requirements for EU-based CA/TSP

NIS2 DIRECTIVE (EU) 2022/2555 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 14 December 2022

- Directive = to be implemented in national law by 27 EU MS
- transposition by MS by 17<sup>th</sup> Oct. 2024 to be applied from 18<sup>th</sup> Oct. 2024 (Art. 41)
- full set for qualified CA/TSP (NIS2, Art 3 1(b), essential entity)
- lightweight set for non-qualified CA/TSP (important entity)
- Under preparation: Implementing Act with further details regarding requirements

- New CCADB field "Network Security Audit Statements"
- NetSec requirements to be added explicitly to the next version release of AAL template set
- Shall be added manually as long as the current template set is in use
